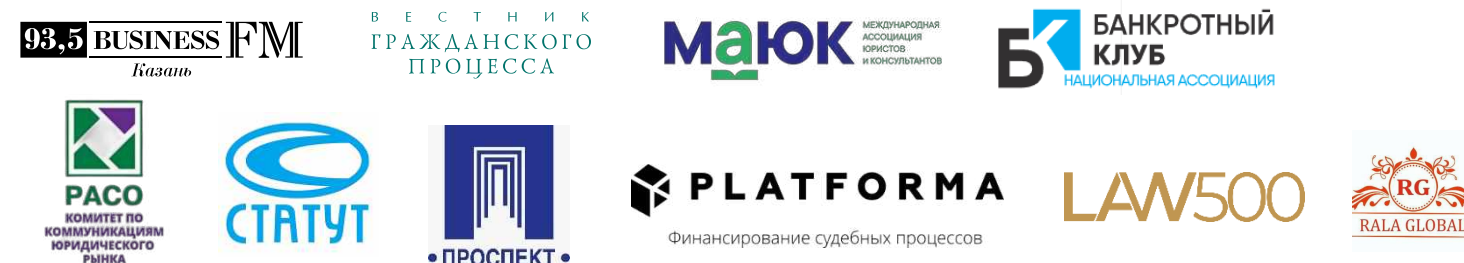

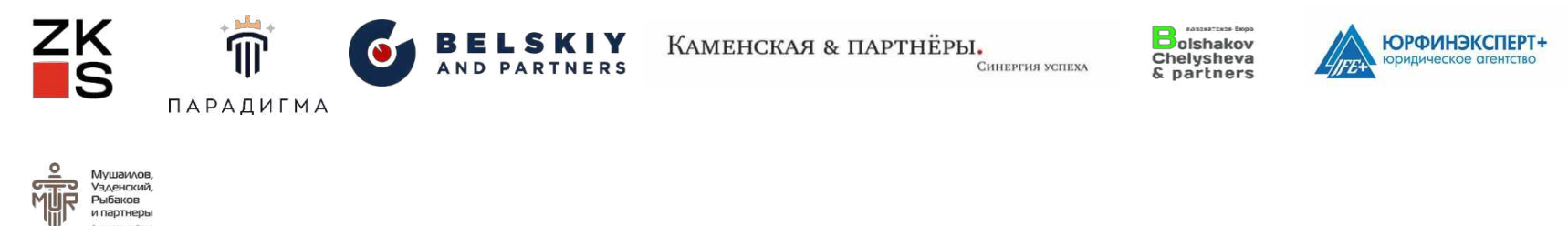

Mission:
